



Marina Rules and Regulations

The following Marina Rules & Regulations (the “Rules”) apply to Sandy Lane Yacht Club (the “Marina”). The Marina retains the right to amend and/or add to the Rules without notice for the safety, care and cleanliness of the Marina or for the preservation of good order.

A. ADMISSION & GENERAL ACCESS

1. **Authorisation Required:** Docking, mooring or otherwise securing of any and all vessels in the marina or any portion of it is permitted only with the written authorization of the Marina by means of a license or similar agreement other than for the nominated guest docks / designated drop off points.
2. **All Vessels Require Examination and Approval** by the Marina Manager (or designated Marina Staff) prior to the execution of a slip/berth license agreement. Vessels are to be maintained in good mechanical and aesthetic condition at all times. Vessels not in good condition as determined at the sole discretion of the Marina Manager will not be admitted or be permitted to remain in the Marina.
3. **Marina Management Reserves the Right to Refuse Admission** to anyone who fails to follow these rules and in general.
4. **Compliance:** The Owner (and/or Captain as applicable) shall comply with all applicable laws and to these rules and regulations and all amendments thereto as are published by the Marina from time to time by posting on the Marina bulletin board, Marina website or located in the Marina office. The Owner and persons associated with the Owner of a vessel, including all family members, agents, employees, licensees or invitees on Marina premises, will comply with the Marina Rules and Regulations.
5. **Access at Own Risk:** The Owner and all persons associated with the Owner of a vessel, including all family members, agents, employees, licensees or invitees on Marina premises, are granted access to and use of the marina and its facilities entirely at their own risk and agree to a full waiver of liability in favor of the Marina.
6. **Responsibility for Injury and Damage:** The Owner shall be responsible for any damages to the docks, equipment at or in the vicinity of its berth and must present proof of liability insurance upon registering at the Marina Reception.

B. BERTHING, MANEUVERING & GENERAL SAFETY

1. **Radars Should Be Switched Off:** Radars must be switched to “Off” position when entering staying in and departing the marina.
2. **No Wake Speed Limit:** The maximum speed limit within the Marina boundaries is the lower of “No Wake” or 5 knots.
3. **Power Driven Vessels Must Give Right of Way:** Any power driven vessel shall at all times give way to yachts under sail while maneuvering in the approaches to or inside the breakwaters, the Marina basin and flushing channel.
4. **Ensure Vessels Are Adequately Moored:** All vessels must be adequately moored. Warps and other equipment shall not be left on the walkway, pontoons, fingers or quays.
5. **All Equipment Must Be Carefully Stored Away:** Dinghies, tenders and rafts shall be stowed aboard the vessel unless a berth is separately provided by the Marina. No stems of boats, gear, equipment, supplies or the like shall be left upon the piers, fingers or pontoons.
6. **No use of Personal Water Craft (“PWC”):** The use of PWC of any type is not allowed in the Marina.

7. **All Children Must Be Supervised and Should Wear a Life Jacket:** Children of 12 and other must be under the supervision of responsible adults at all times and should wear a life jacket at all times while in the forecourt area, walkways, pontoons and quays of the Marina.
8. **No Deliberate Entry into Waterway:** No person shall deliberately enter the water from any part of the Marina or vessel berthed therein.
9. **No Interference with Safety Equipment:** No person shall interfere with lifebelts and other safety equipment. Any interference should be reported immediately to the Marina office.
10. **Reporting of Accidents:** All accidents shall be promptly reported to the Marina office within 24 hours of occurrence.
11. **Check Out Time:** Normal check out time is 12 noon.

C. WASTE & ENVIRONMENTAL MANAGEMENT

1. **No Disposal of Hazardous Material:** Oils, fuels, paints, resins and other hazardous material shall not be disposed of within the Marina.
2. **No Sewage Discharge:** Sewage discharge is not permitted and the use of the vessels onboard holding tanks (either grey or black water) is mandatory. [Should you need to discharge sewage, pump out facilities are available from the Marina office.](#)
3. **Storage and Disposal of Refuse:** All garbage and refuse must be stored on the vessel. Reasonable quantities can be disposed of in containers or bins provided for that purpose by the Marina. [Large and/or unreasonable quantities of garbage require organized disposal at the prevailing fee.](#)
4. **Required Reporting of All Environmental Breaches:** All breaches or potential environmental issues shall be promptly reported to the Marina office.

D. UTILITIES, SERVICES & FUEL

1. **Utility Connections & Meter Readings:** The supply and activation of electricity, water and other services are subject approval by the Marina Manager. Attempts to use or connect to services in non-allocated berths will result in full charges being levied.
2. **Dedicated Fuel Dock:** Users of the Marina shall refuel only at the designated fueling berth and from fuel purchased from the Marina's supply.

E. GENERAL OCCUPANCY RULES & SOCIAL BEHAVIOUR

1. **Other Than Vessel Identification, No Signage Allowed:** Vessels must be clearly identified by name or alternatively by number (to be agreed with the Marina Manager) and shall be readily visible. No commercial signs, advertisements or notices of any kind, shall be displayed to the public view on any berth and boat, without the prior written approval of the Marina.
2. **Only Preventative Maintenance Permitted Without Consent:** Only normal preventative maintenance of vessels is permitted without the prior written consent of the Marina. Use of power tools on the docks or vessel exterior or any painting, varnishing or similar work is not permitted without the prior consent of the Marina Manager.
3. **Owners Remain Responsible for Security & Losses:** The Marina provides security as a matter of courtesy only and accepts no responsibility for theft or loss. All vessels and their contents should be properly secured and are left unattended at Owners risk.

4. **Loud Noises Are Not Permitted:** Loud noises such as music, hailers, unnecessary revving of engines is not permitted. Any noise which can be heard further than two slips from the berth will be considered to be too loud. All noise should be kept to a minimum after 10 pm.
5. **General Nuisances:** Unreasonable, threatening or offensive behavior or bad language is prohibited. No noisy, noxious or objectionable engines, radios or other equipment, apparatus or machinery may be operated with the marina.
6. **No Display of Laundry:** No portion of the Marina, and no boats, shall be used for or the displaying or hanging of laundry; the Marina has a laundry facility to cater the laundry needs of the boat owners, guests and crew.
7. **Pets:** All pets brought into the marina shall be leashed (when not in the boat) and supervised at all times. Pet owners are responsible for cleaning up after their pets. The Marina shall have the right to order the removal of any pet which is considered a nuisance in the Marina at sole and absolutely discretion.
8. **Fish Cleaning:** No fish or other marine life of any kind shall be cleaned, prepared or processed in any manner in the marina. Fish may be cleaned on a boat provided that the boat is properly cleaned afterward.
9. **Fishing:** Fishing is not allowed in the marina.
10. **Open Fire:** No open flames/fires shall be permitted on any boat, berth or anywhere in the Marina, and no charcoal, starting fluids or similarly used substances shall be kept on any portion of the Marina. No open air grilling or propane grills are permitted at any place in the Marina.
11. **Vehicle access to the dockside.** Only SLYCR club carts are permitted to drive on the cobbled pathways along the dock with exception to the island taxi's when picking up or dropping off guests at the boat. If their vehicle is found to be leaking oil then they will not be permitted back until their vehicle is repaired.
12. **Drones.** Due to the proximity to the airport drones are not permitted within the Marina facilities.
